2023-24 Opportunities for Parental Involvement

KIPP Comienza Community Prep highly values parental involvement in school activities. Many times throughout the year we offer opportunities for parents to join in the planning and execution of school activities such as the Winter Festival, fundraising events, Book-fair, and more. Parents often have the opportunity to take the lead with these projects and help plan the events from the ground up. Parents can also volunteer in their child's classroom, office, during morning drop-off, and many other times throughout the day.

For the 23-24 academic year, KIPP Comienza Community Prep has continued to provide parent involvement opportunities in several ways. Lower School has Cafecito with admin in person and Upper School continues to have virtual Cafecitos (Coffee with Admin) to discuss and receive feedback from parents in areas such as student growth, social-emotional support, teaching and learning, school highlights, etc. KIPP Comienza Community Prep also participates in Family Leadership Academy where a group of family members and staff members will learn how to become leaders and advocates for their students, school, and community. Various meetings are hosted throughout the year to cover different topics such as What is a charter School, Using your voice to make real change (Advocating), California Dashboard/School Performance, Review LCAP School Plan, and Understanding Accountability.

Currently, the Counseling Team has facilitated in-house parent workshops on several topics such as how to support your child in navigating social media drama, strengthening communication skills, active listening skills, emotion regulation, and much more. The counselors provide communication via ParentSquare to ensure parents remain informed of workshops and are encouraged to participate. Parent Square is also utilized to inform families of resources available in their community. Counselors also assist with supporting students and their families with case management services on an as-needed basis to help support families with basic and or social-emotional health needs. Lastly, the counselors target several monthly initiatives via social-emotional lessons that range in topics from suicide, mental health, bullying, kindness, Latinx Heritage month, Black History Month, Racism, Inequality, and much more. The purpose of our lessons is to build awareness of emotions, and the impact several topics have on the individual and to provide safe spaces for students to build community with others whilst having impactful conversations.

KIPP Comienza offers an Expanded Learning Program funded afterschool program to assist and support our students. Our program aims to continue the support students receive during the regular school day in a safe, constructive environment during after-school hours. Our program provides literacy and enrichment activities for approximately 287 students, grades TK through 8th. Every student in our program participates in a daily literacy and enrichment component. Our literacy programs provide tutoring and homework help in the core areas of reading, language arts, mathematics, and science. Students use software to ensure they are reading and completing math at their own levels. Students participate in at least one hour daily in a literacy element. Our educational enrichment programs align with the school's academic program and include, but are not limited to, recreation and prevention activities such as football and cheerleading and youth development strategies like performing arts, music, and dance. Other enrichment activities are implemented based on the student's needs and interests.
