The building itself is over 100 years old but was completely remodeled and brought up to modern code in 2017 (Fire, Electrical, Seismic Fitting, Technology and More).

Since 2020, the building has seen multimillion dollar investments across the entire facility:

3. Updated and renovated staff MPR and Lounge
4. Installation of brand new ceiling mounted projectors, appletvs, recessed sound w microphones.

7. Installation of a Community Garden
8. Upgraded outdoor lighting and installation of filtered potable water systems for students
9. Purchase of a professional stage and chairs for student performances
10. Purchase of a theater quality sound system for school performances.

2023-24 School Safety Plan

The safety and security of all KIPP Vida Preparatory Academy students and staff is our highest priority. All staff members receive training in a variety of emergency scenarios and use practice drills conducted every month to develop and grow our preparedness. The current safety plan was created in August 2023 and finalized in October 2023 and continues to be discussed with staff following each emergency drill. Members of KIPP Vida Preparatory Academy's staff receive general emergency preparedness training before school starts /during summer presentations, and prior to each monthly drill.
