Where the most viable option, LEAs were required to administer the statewide summative assessment in ELA and mathematics. Where a statewide summative assessment was not the most viable option for the LEA (or for one or more grade-level[s] within the LEA) due to the pandemic, LEAs were allowed to report results from a different assessment that met the criteria established by the State Board of Education (SBE) on March 16, 2021. ### Percentage of Students Meeting or Exceeding the State Standard on CAASPP

The 2020-21 data cells have N/A values because these data are not comparable to other year data due to the COVID-19 pandemic during the 2020-21 school year. Therefore, the 2020-21 data between school years for the school, district, state are not an accurate comparison. ### 2022-23 School Safety Plan

KIPP LA Prep reviews and updates its safety plan every year. This year's plan was reviewed and updated in October 2022. As a primary concern of KIPP LA Prep, all visits during regular school hours should be arranged with the school admin and office team 24 hours in advance. Upon entering KIPP LA Prep, all visitors shall immediately register in the front office. Additionally, all visitors must wear a school identification badge to be easily recognizable. The School leader has the right to refuse any visitation for any reason. Supervision is provided to ensure the safety of each student before school, during breaks, at lunch, and after school. To further safeguard the well-being of students and staff, a comprehensive School Site Safety Plan has been put in place. It includes monthly safety drills incorporating earthquake, fire, and soft and hard lockdowns. KIPP LA Prep also participates in the CA Great Shake drill, where we initiate our incident command center. During this drill, we complete search and rescue, have a first aid station, and practice reunification by allowing parents to "pick up their kids" during an emergency. Practicing drills is an excellent way for staff members to know their roles and ask questions if needed.
